Now, the industry has proposed to increase its manufacturing capacity of existing products & to add some new products as well as to add formulation process by acquiring additional 67.12 acres of land, the details of production capacity is as under:-

the procedure for seeking environmental clearance, as notified by MoEF&CC, the project proponent has prepared draft EIA study report of the proposed project based on the Terms of Reference issued by the MoEF&CC, New Delhi, vide No. IA-J-11011/98/2024-IA-II(I) dated 15.03.2024. The industry had submitted draft EIA study report to the Board and had requested for conduct of public hearing of this project.

In compliance to the provisions of the EIA notification dated 14.09.2006 & Office Memorandum dated 14.09.2020, the Board fixed the date of public hearing as 08.07.2024. Public notices were published in two daily newspapers namely 'The Times of India' & 'Punjabi Jagran' on 08.06.2024 for getting responses from public and intimating date, time & venue of public hearing. The copies of the said notices are enclosed herewith as Annexure-I. The public announcements and banners were displayed in the vicinity / nearby villages to give the wide publicity of the public hearing by the Board. Thereafter, public hearing for the said project was conducted on 08.07.2024. The public hearing process was supervised and presided over by the Additional Deputy Commissioner (D), Barnala in the presence of Environmental Engineers, Punjab Pollution Control Board, Regional Office, Sangrur. The public hearing was attended by 209 persons and the entire process of the said hearing was videographed. A copy of the attendance containing the details of persons, who attended the said hearing along with copy of the Pen drive containing video recording, is enclosed herewith as Annexure-II & III, respectively.
