Proceedings of the public hearing conducted on 08.07.2024 in connection with application filed by M/s Olives Laboratories, for obtaining environmental clearance under EIA notification dated 14.09.2006, for setting up of Active Pharmaceutical Ingredients (API) manufacturing unit of 7.49 MTPA in the revenue estate of Vill. Ballopur, Tehsil Dera Bassi, District SAS Nagar.

It is intimated that the subject cited industry has proposed to set up Active Pharmaceutical Ingredients (API) unit for the manufacturing of pharmaceutical products @ 7.49 MTPA in an area of 36,000 sq. ft in the revenue estate of Village Ballopur, Tehsil Dera Bassi, District SAS Nagar. The project is covered under the EIA notification No. S.O. 1533 (E) dated 14.9.2006 issued by Ministry of Environment, Forest & Climate Change, (MoEF&CC), Govt. of India, New Delhi and thus, the industry is required to obtain Environmental Clearance from MoEF&CC, New Delhi. As a part of the procedure for seeking environmental clearance, as notified by MoEF&CC, the project proponent has prepared draft EIA study report of the proposed project based on the Terms of Reference issued by the MoEF&CC, New Delhi, vide No. IA-J-11011/342/2023-IA-II dated 14.12.2023. The industry had submitted draft EIA study report to the Board and had requested for conduct of public hearing of this project.

In compliance to the provisions of the EIA notification dated 14.09.2006 & Office Memorandum dated 14.09.2020, the Board fixed the date of public hearing as 08.07.2024. Public notices were published in two daily newspapers namely 'Indian Express' & 'Punjabi Tribune' on 08.06.2024 for getting responses from public and intimating date, time & venue of public hearing. The copies of the said notices are enclosed herewith as **Annexure-I**. The public announcements and banners were displayed in the vicinity / nearby villages to give the wide publicity of the public hearing by the Board. Thereafter, public
