Proceedings of the public hearing conducted on 15.11.2021 in connection with application filed by M/s Mahadev Enclave Pvt. Ltd., H.No. 55-C, Shaheed Bhagat Singh Nagar, Pakhowal Road, Ludhiana for obtaining environmental clearance under EIA Notification dated 14.09.2006 for mining of minor minerals (sand) on Agricultural Land on bed of River Sutlej in the revenue estate of Village Kaniya Hussaini, Tehsil Jagroan, District Ludhiana.

It is intimated that the subject cited project proponent has applied to SEIAA, Punjab for obtaining environmental clearance for mining of minor minerals @ 78,737 TPA in an area of 7.68 hectares situated in the revenue estate of Village Kaniya Husaini, Tehsil Jagraon, District Ludhiana. The project is covered under Ministry of Environment Forest & Climate Change (MoEF&CC), Govt. of India, notification no. S.O. 1533 (E) dated 14.09.2006 and thus is required to obtain environmental clearance from SEIAA, Punjab. The 'Terms of Reference' for preparing draft EIA study report for the said project have been prescribed by the SEIAA, Punjab vide No. DECC/SEIAA/2020/2007 dated 08.09.2020. Accordingly, the project proponent had submitted draft rapid EIA study report alongwith summary report of the same to the Punjab Pollution Control Board and requested for conduct of the public hearing for the proposed project.

In compliance to the provisions laid down in the EIA notification dated 14.9.2006, the date of public hearing for the project was fixed as 15.11.2021 at Sub Health Centre, Village Kaniya Husaini, Tehsil Jagraon, District Ludhiana and the public notice of 30 days in this regard was issued in two daily newspapers namely 'Hindustan Times' & 'Rozana Spokesman' on 12.10.2021 for getting responses from public and intimating time, date & venue of the public hearing. A copy of the said notices is enclosed herewith as Annexure-I.
