Proceedings of the public hearing conducted on 12.06.2024 in connection with application filed by M/s K.L. Alloys (P) Ltd., for obtaining environmental clearance under EIA notification, 2006 for the proposed expansion in the existing premises located in the revenue estate of Vill. Ambey Majra, G.T. Road, Sirhind Side, Mandi Gobindgarh, Tehsil Amloh, District Fatehgarh Sahib.

It is intimated that the subject cited industry is an existing unit located in an area of 2.6375 acres located in the revenue estate of Village Ambey Majra, G.T. Road, Sirhind Side, Mandi Gobindgarh, Tehsil Amloh, District Fatehgarh Sahib and is engaged in the manufacturing of Steel ingots/billets, MS Rounds, TMT Bars, Flats @ 28,700 TPA by installing an induction furnace of 7 Ton/heat capacity, 1 No. Rolling Mill of 18 TPH capacity and a concast machine. Now, the industry has proposed to increase its manufacturing capacity of Steel ingots/billets, MS Rounds, TMT Bars, Flats from 28,700 TPA to 1,57,500 TPA (Total after expansion) in its existing premises by replacing existing induction furnace of 7 ton/heat capacity with 2 no. induction furnaces of 15 Ton/heat capacity each besides existing Rolling Mill of 18 TPH capacity & concast machine (CCM). The project is covered under the EIA notification No. S.O. 1533 (E) dated 14.9.2006 issued by Ministry of Environment, Forest & Climate Change, (MoEF&CC), Govt. of India, New Delhi and thus, the industry is required to obtain Environmental Clearance from State Environment Impact Assessment Authority (SEIAA), Punjab. As a part of the procedure for seeking environmental clearance, as notified by MoEF&CC, the project proponent has prepared draft EIA study report of the proposed project based on the Terms of Reference issued by the SEIAA, Punjab, vide No. SEIAA/MS/2022/257 dated 12.07.2022. The industry had submitted draft EIA

In compliance to the provisions of the EIA notification dated 14.9.2006 & Office Memorandum dated 14.09.2020, the date of public hearing was fixed as 28.03.2024. Public notices were published in two daily newspapers namely Times of India' & 'Punjabi 'Jagran' on 24.02.2024 for getting responses from public and intimating date, time & venue of the public hearing. The copies of the said notices are enclosed herewith as Annexure-I. Thereafter, the above-mentioned public hearing was postponed to 12.06.2024 due to imposition of Model Code of Conduct w.r.t. General Lok Sabha Elections-2024. The public notice was got published in the same newspapers in which earlier public notice was published i.e. 'Times of India' & 'Punjabi 'Jagran' on 23.03.2024, copies of the same are attached herewith Annexure-II. The public announcements and banners were displayed in the vicinity / nearby villages to give the wide publicity of the public hearing by the Board. Thereafter, public hearing for the said project was conducted on 12.06.2024. The public hearing process was supervised & presided over by the Sub Divisional Magistrate, Amloh, District Fatehgarh Sahib in the presence of Environmental Engineer & Asstt. Environmental Engineer, PPCB Regional Office, Fatehgarh Sahib. The public hearing was attended by 50 persons and entire process of the said hearing was videographed. A copy of the attendance containing the details of persons, who attended the said hearing along with copy of the (Pendrive) containing video recording, is enclosed herewith as Annexure-III & IV, respectively.

The proceedings of the public hearing reflecting the views & concerns expressed during the public hearing, duly signed by the Sub Divisional Magistrate, Amloh, District Fatehgarh Sahib in the presence of Environmental Engineer & Asstt.
