Proceedings of the public hearing conducted on 16.08.2024 in connection with application filed by M/s Lactitol India Private Ltd., for expansion of the existing unit located at 06 km Stone, Derabassi Barwala Road, Village Bhagwanpur, Dera Bassi, District SAS Nagar.

It is intimated that the subject cited industry is an existing unit located in an area of 14,429.47 sqm (1.44 ha) at 06 km Stone, Dera Bassi Barwala Road, Village Bhagwanpur, Dera Bassi, District SAS Nagar and is engaged in the manufacturing of Lactose of Pharma Grade @ 350 TPM. Now, the industry has proposed to expand its unit in the existing premises for manufacturing of Lactulose @ 200 TPM, Lactitol monohydrate @ 100 TPM & Active Pharmaceutical Ingredients (API) @ 9211 kg/month in addition to existing manufacturing capacity of Lactose of Pharma Grade @ 350 TPM. The project is covered under the EIA notification No. S.O. 1533 (E) dated 14.9.2006 issued by Ministry of Environment, Forest & Climate Change, (MoEF&CC), Govt. of India, New Delhi and thus, the industry is required to obtain Environmental Clearance from MoEF&CC, New Delhi. As a part of the procedure for seeking environmental clearance, as notified by MoEF&CC, the project proponent has prepared draft EIA study report of the proposed project based on the Terms of Reference issued by the MoEF&CC, New Delhi, vide No. IA-J-11011/44/2024-IA-II(I) dated 15.02.2024. The industry had submitted draft EIA study report to the Board and had requested for conduct of public hearing of this project.

Office Memorandum dated 14.09.2020, the Board fixed the date of public hearing as 16.08.2024. Public notices were published in two daily newspapers namely 'Times of India' & 'Punjabi Jagran' on 16.07.2024 for getting responses from public and intimating date, time & venue of public hearing. The copies of the said notices are enclosed herewith as Annexure-I.
