SECTION – III

TERMS AND CONDITIONS OF THE TENDER

1. TENDERER'S QUALIFICATION: -

1.1 The tenders company must have offices in Chandigarh / Punjab and have valid Income Tax Clearance Certificate. Only well- established firms are eligible to tender if they have adequate direct in-house facilities for servicing equipment at Chandigarh or Patiala.

Explanation: A firm will be considered well-established if:

- (a) It has been in existence in this line under its own present name for at least three years and, in addition,
- (b) It has been income tax payee under the same name for at least three years.
- (c) As It has **AMC of minimum 2.00 lacs per year AMC in last three years.**

2. EARNEST MONEY & SECURITY:

4. Rates for A, B, C & D may be quoted separately.

5. Annual Maintenance Contract Conditions:

- 5.1 Rates should include charges for providing a Resident Engineer for minimum of 4 hrs. daily on all working days in Punjab Pollution Control Board, Nabha Road, Patiala. After any repair being done, the Resident Engineer will certify its proper functioning by signing in logbook. The Resident Engineer will mark his attendance in logbook maintained in the Board Office. The payment for the absent period of the Resident Engineer will be deducted from the last installment of AMC on pro-rata basis before making the final payment. In addition, the selective vendor will provide Resident Engineer who will perform preventive maintenance of all items under AMC of Head Office.
- 5.2 Bidders having office in Patiala shall have preference.
- 5.3 Response time will be within 4 hours of logging of call at our office either orally or in writing, failing which suitable penalty may be imposed.
- 5.4 In case a machine remains down beyond 48 working hours during PPCB working days suitable standby shall be provided.
- 5.5 The AMC includes replacement of unserviceable parts in computers (Complete System), Printer, UPS (except batteries of UPS) etc. other than physically broken / damaged. The rate quoted should be including the cost of repair & spares, if any, the replaced part shall belong to the tenderer.
