Subject: CPCB Clarification Re- invoking section 197 Cr.P.C against officials of Deptt. of Local Bodies in the Court of competent jurisdiction.

Find enclosed herewith the subject referred clarification received from the Central Pollution Control Board vide letter no. Legal (Misc.)/2019/116 dated 2.4.2019.

The CPCB has clarified that the State Pollution Control Board are empowered under section 48 and section 60 of Water (Prevention & Control of Pollution) Act, 1974 to file criminal complaint against the officials of Deptt. of Local Bodies. The Hon'ble Supreme Court vide its judgment dated 10.3.2015 in the matter of V.C. Chinnappa Goudar Vs. Karnataka State Pollution Control Board and Anr. has also held that there is no scope for invoking section 197 Cr.P.C. even though the Appellants are stated to be public servants. In view of above, State Pollution Control Boards may proceed to file criminal complaint in the court of competent jurisdiction as required.

This is with reference to your letter, dated 20.03.2019 regarding issues discussed in the 63rd Conference of Chairmen and Member Secretaries, State Pollution Control Boards held in New Delhi on 18.03.2019. The issues regarding filing of criminal complaints against officers of the Department of Local Bodies under the Water (Prevention and Control of Pollution) Act, 1974 in the Court of Competent Jurisdiction was discussed.

The matter has been examined. The State Pollution Control Boards have powers to prosecute officers of Department of Local Bodies under the Water (Prevention and Control of Pollution) Act, 1974. The State Pollution Control Boards are empowered under Section 48 and Section 60 of the Water (Prevention and Control of Pollution) Act, 1974 to file Criminal Complaint against the officials of the Department of Local Bodies. The Hon'ble Supreme Court vide its Judgment, dated 10.03.2015 in the matter of V.C. Chinnappa Goudar Vs Karnataka State Pollution Control Board & Anr. has also held that there is no scope for invoking section 197 Cr.P.C even though the Appellants are stated to be public servants.

In view of the above, the State Pollution Control Boards may proceed to file Criminal Complaint in the Court of competent jurisdiction as required.
