
Subject:- Regarding visiting and collection of effluent samples of the Large and Medium scale industries.

Vide circular dated 12/11/2012, it has already been circulated in the Board that all the Large and Medium scale industries should be visited by the Environmental Engineers of the Regional Offices, personally. Similarly, it has been also been ordered that samples of such type of industries should be collected by a team of officers accompanied by the Environmental Engineer of the concerned Regional Office. However, it has come to the notice that these instructions are not being followed by the Environmental Engineers working in the various Regional Offices of the Board and they leave the work on the shoulders of the Assistant Environmental Engineer. The matter has been viewed seriously.

In view of the above, it is again instructed that all the large and medium scale industries should be visited by the Environmental Engineers working in the Regional Offices of the Board. The Environmental Engineers working in the Regional Offices will also collect the effluent samples of large & medium scale industries for the parameters as prescribed by the Board under Environmental Protection Act, 1986. The preservation of the samples for the various parameters should be carried out as per the prescribed procedure. The incomplete analysis results should also not to be conveyed to the industry as well as Regional Office.

These instructions must be brought to the notice of the technical/scientific staff working in the field offices as well as head office.
