The Healthcare Facilities operating under your jurisdiction may be directed to sign fresh agreement with the CBWTF operators as per the re-distributed area (incase of change in CBWTF operator) and clear all the previous pending payments till 31.01.2019 of the previous CBWTF operators immediately.

This order will come into effect wef 01.02.2019 and will supersede all previous orders issued in the subject cited matter. This order is issued with the approval of the Competent Authority.
