I am directed to refer you on the subject cited above and to intimate that State Government vide letter No.1/54/2000-4Judl(1)/583 dated 20.3.2001(copy enclosed) has already issued detailed instructions regarding procedure to be followed for proper defence of Court Cases in the Hon'ble Punjab and Haryana High Court/Supreme Court. But, it has come to notice that various departments of State are not following the procedure laid down in above said instructions, while defending the cases in the High Court/Supreme Court. It is, therefore, again advised that instructions dated 20.03.2001, is to be complied in strict manner and in case of non-compliance of these instructions, concerned department shall be held responsible for lapses.

Subject: Procedure to be followed for proper defence of cases in the High Court/
Supreme Court.

Sir,

I am directed to address you, on the subject noted above and to say that the question regarding proper defence of court cases in the Hon'ble Punjab and Haryana High Court/Supreme Court has been under consideration of the State Government for some time past. It has now been decided that in future, the following procedure will be adopted:-

- i) The Administrative Department will issue instructions for the defence of cases at Public expenses in the High Court as well as in the Supreme Court, to Advocate General, Punjab, instead of Director, Prosecution and Litigation, Punjab.
- ii) The Advocate General, Punjab shall send the copies of Judgement etc. in civil cases to the concerned Administrative Department, tendering his opinion to the effect as to whether the case is fit/not fit for filing appeal/revision/review etc. for taking final decision by the Administrative Department, in this regard.
- iii) The Advocate General, Punjab will send the Copies of the Judgements in Criminal cases decided by the High Court along with his opinion to Home Department for taking final decision as to whether any further action is to be taken or not.
- iv) The Director, Prosecution and Litigation, Punjab will send his opinion in all Criminal/Civil cases, decided by the Subordinate Courts, to Advocate General, Punjab, who will inturn send his recommendations along with reasonable Grounds to Home Department for taking final decision as to whether the appeal is to be filed/or not in Criminal cases and to the concerned Administrative Department in Civil Cases.
