Office Order

The Board has constructed its own office buildings at various locations in the State of Punjab for its working. It is observed that maintenance of these office buildings is not being carried out properly and the condition of these buildings is found to be deteriorating day by day by the Senior Officers of the Board. To improve the conditions of office buildings it is decided to upgrade the construction wing of the Board by creating central construction division at Head Office and at Regional Office level and to delegate Financial Powers to the officers of the Board for maintenance of the concerned office buildings as under:

Note:

- 1. In case of Ludhiana, the work regarding maintenance of buildings shall be looked after by Environmental Engineer, Regional Office-I, Ludhiana.
- All the concerned Regional Environmental Engineers will decide the cases as per their competency and shall send a copy of the orders passed to Environmental Engineer (Construction), Head Office, Patiala for information and record.
- 3. All the concerned Regional Environmental Engineers will route other cases (beyond their competency) regarding maintenance of the office building through Environmental Engineer (Const.), Head Office, Patiala for necessary decision / orders as per competency assigned. In these cases, necessary office orders after approval of competent authority shall be issued by Head Office Branch.
- 4. Work would be carried out as per the norms and instructions of the Government after adopting the proper procedure. The necessary record of various approval be kept in the concerned Regional Office as well as Head Office of the Board.
- 5. Construction wing of Head office Patiala will check the office buildings other than Head Office building atleast once a year to keep check the maintenance & upkeep and report accordingly.
- 6. The cornered Environmental Engineer Regional Office shall be responsible for the proper maintenance of the buildings.

These orders will come into force with immediate effect.
