The Board in its 174th meeting held on 23.12.2016 considered the matter in detail regarding the standards for the discharge of treated domestic effluent at the outlet of sewage treatment plant (STP) for the various towns in the State of Punjab notified vide Board's notification no. SEE(HQ-2)/2016/F.No. Standards/70/370 dated 16.08.2016.

Keeping in view the techno-economic non-feasibility, it has now been decided to amend the said notification and to waive off parameters namely SAR, EC and RSC at the outlet of the sewage treatment plant (STP) of capacity less than 10 MLD. However, the said parameters will remain applicable for STPs of capacity 10 MLD or above.

This will come into force with immediate effect.
