Office Order

It has been observed that the applicability and compliance of EIA notification in the construction projects is not clearly stipulated by the Regional Officers while processing consent applications of such projects. Worthy Chairman, while conducting personal hearings of such cases has taken a very serious view of the same. As such, it has been decided as under:-

1. All ROs shall ensure that applicability of EIA notification in the construction projects is specifically mentioned in each case while processing its applications.
2. In construction cases, where, SEIAA has issued directions that the project proponent shall not carry out any further construction activity at its project site till it obtains EC under EIA notification dated 14.9.2006, following procedure should be adopted:-

" Concerned EE, RO shall ensure that at the time of issuance of above directions by SEIAA or any other competent authority, a complete photography/videography of the project be done and a copy of the CD in sealed and signed covers be retained in RO as well as sent to concerned ZO. The CD should be readable only/non editable so as to serve as a adequate evidence for violations by the project proponent in future."

These orders are issued with the approval of the Chairman of the Board and shall come into force with immediate effect.
