## OFFICE ORDER

**Sub: Regarding grant of 'Consent to Establish' (NOC) from pollution angle after the issuance of Environmental Clearance under press note 17 (1984 Series) / Site Clearance under Factories Act, 1948 by SCA-Cum-SAC.**

As per the prevailing practice, as and when the Environmental / Site Clearance is granted by SCA-cum-SAC, 'Consent to Establish' (NOC) is granted on the basis of documents submitted by the project proponent for site approval / clearance in offline mode by concerned ~~Office~~ Office.

In order to maintain data of SCA-cum-SAC applications online, it has been decided that after the grant of Environmental Clearance / Site Clearance by SCA-cum-SAC, the industry will be asked to upload the application for obtaining 'Consent to Establish' (NOC) of the Board through OCMMS. The Regional Offices shall also upload the earlier report submitted for SCA-cum-SAC clearance while forwarding the 'Consent to Establish' application of the industry to the Zonal office. However, no verification would be carried out by the Regional Offices while forwarding the case to the officer concerned.
