OFFICE ORDER

As you are aware that presently number of applications / writ petitions are coming before the Hon'ble National Green Tribunal, Hon'ble Punjab and Haryana High Court, Hon'ble Delhi High Court and Hon'ble Supreme Court of India regarding various issues on the environment. Therefore, a comprehensive reply consisting of number of components is to be prepared for filing the reply before the Hon'ble Courts / APEX Court. For preparing the status report / affidavit to be filed before the Hon'ble Courts / APEX Court, the information / data is collected from various officers / branches of the Board. These information / data is sent by the officers through email or through hard copy without any signature. But, whenever these officers are asked to sign the information / data, these officers do not take the responsibility to sign these papers on the plea that he was only asked to prepare the information but it does not pertain to him or his branch.

The competent authority of the Board has taken the matter seriously and has decided that any information / data prepared by any officer / branch must be signed by the concerned person because these information are to be supplied before the Hon'ble Courts / APEX Court, failing which the disciplinary action will be taken against the concerned officer. The matter must be taken up seriously and no excuses shall be tolerated.

These orders shall come into force with immediate effect.

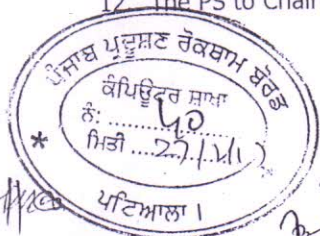
