**Order**

Punjab Pollution Control Board in its 179th meeting held on 28.03.2018, vide item no. 179.07 approved creation of Environment Protection Fund in the Board. The companies/project proponents, general public, serving or retired employees of Board or any other organization desirous of undertaking environmental amelioration activities can contribute to this fund. The Board will utilize this fund on the following activities pertaining to protection of environment in the State of Punjab:

- i) Tree plantation and or environmental cleaning activities.
- ii) Funding of R & D activities for environment protection/upgradation
- iii) Funding for activities related to control of air/water/noise/soil pollution or any other environment protection activity.
- iv) Providing financial and technical assistance for setting up or running of waste management facilities i.e. for plastic waste, hazardous waste or any other waste with a view to dispose it off in an environmentally sound manner and to reduce recycle or reuse it.
- v) Providing financial/technical assistance for setting up and running of STPs/ETP with a view to control water pollution.
- vi) To undertake activities for cleaning of drains, rivers, rivulets etc. and to take up activities for water conservation, recharging or cleaning of polluted surface or subsoil water.
- vii) To undertake awareness creation activities to control pollution through audio visual aids and through any other means/activities.
- viii) Any other activity, which can be useful for protection of environment of the State and for activities which improve the environment of the State to make it healthy and liveable.
