**Subject. Clarification regarding adoption of siting criteria framed for poultry farms.**

Central Pollution Control Board (CPCB) vide its letter no. B-4032/PCI-SSI/poultry-2015/13165 dated 20.10.2015 has framed and circulated environmental guidelines for control of pollution from Poultry Farms. As per these guidelines, siting criteria for setting up of new poultry farms has also been framed vide which one of the distance is as under:-

"500 m from nearby poultry, dairy or another livestock enterprises or industry".

However, it has been observed that some Regional Offices are using the distance of 500 m from nearby poultry or industry vice-versa i.e. this siting criteria is also being implemented on a new industry other than poultry farm to be set up near poultry farm.

The siting criteria framed for the poultry farms should only be implemented on the poultry farms and the same should not be implemented vice-versa on any other industry.

It is, hereby, clarified that the above mentioned siting criteria shall be adopted only for new poultry farms to be set-up and shall not be adopted vice-versa for establishment of any industry.
